FROM WITHIN THE BOWLES OF THE AMERIKKKA'S BABYLON SLAVE SHIP OF GENOCIDAL MASS INCARCERATION, OF THE SURVEILLANCE, CARGERAL CAPITALIST PLANTATION SLAVERY EMPIRE, I send my revolutionary love to all, my rage against the racist, fascist machine, hoping all are well, and that my writings, essays, words, and deeds, move all into a social and class awareness, and take a moment of your time to see what is now happening in this country, in these critical times of resistance, and revolution, yes, I said revolution, because that is what's going to have to take place to push back the RISE OF FASCISM that has taken hold in AMERIKKKA, given the examples of the JANUARY 6th right-wing fascist insurrection by white supremacists-in-chief DONALD J. TRUMP, and his loyalists, such as THE PROUD BOYS, THE OATH KEEPERS, THE PATRIOTIC FRONT, AND THE TEXAS REPUBLICAN PARTY, which just held their state convention in Houston last week, and who continue to embrace, and pursue TRUMP'S "marching orders" they all seek to win back the HOUSE, THE SENATE, THE WHITE HOUSE, in the 2023 and 2024 elections, by any and all illegal means and trickery. The recent right-wing, fascist decisions that just came down from the U.S. SUPREME COURT on overruling the 1973 ROE V. WADE decision on a women's right to an abortion, the New York Gun rights decision, the overruling of the right of citizens to sue federal law officers, overturning BIVENS V. SIX UNKNOWN AGENTS, 1971, and other right-wing decisions, demonstrates that the 6-3 majority right wing ultra conservative court, manufactured by DONALD J. THOMAS, in his "Concurring opinion" in overruling ROE V. WADE, suggested that the Court should now undertake to review and overrule all other decisions, such as gay marriages, birth control, and, certainly, going back to the old "hands off doctrine;" pertaining to the old court decisions that, as slaves of the state, prisoners are "state property," and society has no say so on how prisoners are treated, as they have no legal, or human rights the state or society is bound to respect, much like the Court's decision in the DRED SCOTT V. SANFORD, 60 U.S. (19 HOW.) 393 in 1857, finding that Blacks "had no rights which the white men were bound to respect," and Blacks were only 3/4ths of a human being, a base which was known historically as "the trigger for the U.S. Civil War." MAY SUCH FASCIST RIGHT WING ACTIONS WAKE US ALL UP, OR SHALL WE LIVE IN SHAME AND INFAMY, AS FUTURE GENERATIONS WILL DISOWN OUR GENERATION FOR COMARDICE, AND TREACHERY OF, IN THE FACE OF SUCH FASCIST REPRESSION, WE DID LIKE THE COWARDLY OSTRICH AND PRETENDED THIS ALL IS NOT HAPPENING TO CIVIL SOCIETY, IN THE SO-CALLED BASTION OF FREEDOM, JUSTICE AND LIBERTY FOR ALL. ALL IMPERIALIST LIES TO MANIPULATE, DECIEVE AND CONTROL....WE MUST NOT BURY OUR HEADS IN THE SAND, LIKE THE OSTRICH.....

INSIDE TEXAS PRISON WALLS, on JUNE 21st the prison confiscated our TENNIS SHOWS, we paid \$50.00 a pair, claiming that GONAZLO LOPEZ, who last month overpowered the medical chain bus, stabbed the driver, commandered the prison bus, crashed it and made his getaway, into thw woods in LEON COUNTY, TEXAS, near CENTERVILLE and HOUSTON; LOPEZ, an alleged MEXICAN MAFIA GANG MEMBER housed in "administrative segregation" was wearing a pair of TENNIS SHOES, which prisoncrats say, facilitated him navigating through the piney woods in his REEBOK TENNIS SHOES, and so now the prison confiscated all of our TENNIS SHOES, leaving most, if not all, of us with mere "shower slides," as the prison ran out of the state-issued sneakers they pass out to indigent prisoners without funds to purchase the \$50.00 commissary-bought TENNIS SHOES. This action by Texas prison officials was taken in the wake of TEXAS STATE SENATOR JOHN WHITMIRE, CHAIR, CRIMINAL JUSTICE COMMITTEE, who oversees Texas prisons for the Legislature, and WHITMIRE'S outrage and disgust at the incident in that LOPEZ during his escape killed four children and their Grandfather out companing in the county, stealing their truck, being accosted by law officers on the highway and shot and killed. Reports says LOPEZ was shot 36 times and the truck was full of bullet holes. So, this is the state of "corrections" in the State of Texas this very momenet, and we, prisoners in AD. SEG. expect more retributory, retaliatory prison rules and laws to punish us, indiscriminately, and systematically, in blanket-form, although we had nothing to do with the LOPEZ incident; Moreso, if you are a BROWN-SKINNED MEXICAN [LOPEZ WAS A MEXICAN from HIDALGO CO. TEXAS], and "flagged" with the "prison gang securityythreat tag," you are in for discriminatory, racially-profiled brutalities and repression by the prison; some prison guards, and higher-ups coming in front of my prison

Prison psychologits, psychiatrists, and experts on "corrections" should not be surprised with the barbarity and cruelty that GONZALO LOPEZ committed his heinous crimes, in the killing of 5 innocent souls, out camping in the woods, he came up on., in his desperate bid for freedom, from racist and barbaric conditions that today exist throughout all "ad. seg." control units in the State of Texas, housing us, many like me, who have been in solitary confinement, stripped of all enviornmental stimulation, harassed daily, denied adequate medical care, fed horrific food, subjected to the use of dangerous chemical agents without provocation, sprayed with tear gas inside of our cages, us posing no threat to anyone; given false disciplinary cases, having our mail, and our LEGAL AND POLITICAL WRITINGS, DOCUMENTS AND ESSAYS, such as the fliert I composed on the upcoming 2023 BICENTENNIAL ANNIVERSAY of the birth of the TEXAS RANGERS, and the REPUBLIC OF TEXAS, 1823-2023, denouncing the history of settler colonialism, white supremacy, slavery, and the interconnection between U.S. Yankee colonialism and its orison system, and use of prison slaves in its LEASE-A-CONVICT PROGRAM in building colonial Texas, and the mansions and the State Captiol Building in AUSTIN, TEXAS, and the continued neo-colonial criminal structures that is the DNA of the STATE OF TEXAS, all stained with the blood of prison slaves, mostly Black and Mexican prison slaves, when chatten slavery was converted into prison slavery all legalized by the 13th Amendment to the U.S. Constitution in 1865. In other words, TEXAS STATE PRSIONS ARE BUT MERE HATE FACTORIES OF BARBARISM THAT IS PRODUCING THE MONSTERS OF FRANKENSTEIN WE SAW IN THE IMAGE OF GONZALO LOPEZ, EXPRESSING HIS HATE AND CRUELTY ON INNOCENT MEMBERS OF SOCIETY, WHOSE TAXPAYING DOLLARS GO TOWARDS SUPPORTING AN OLD, ARCHAIC, MEDIEVAL, OPPRESSIVE, CRUEL AND CRIMINAL PRISON SYSTEM, AND ITS FASCIST PHILOSOPHY ON "CORRECTIONS," TAUGHT IN PSYCHOLOGY SCHOOLS IN STATE UNIVERSITIES SUCH AS SAM HOUSTON STATE UNIVERSITY IN HUNTSVILLE, TEXAS, and throughout the state, responsible for creating these MONSTERS OF FRANKENSTEIN. When you cage human beings and mistreat them worse than animals in a Zoo, deny them their human dignity and torture their hearts and souls, YOU ARE CREATING MANY FRANKENSTEINS OF THE FUTURE!
