

.....[TDCJ officials] have [...] caused violent attacks to be perpetrated on writ-writers, in retaliation for their legal activity. Various inmates testified that they have repeatedly suffered brutality at the hands of [TdcJ] employees because of their writing. One notoriously violent inmate was instructed by higher-ups to prey upon one of the plaintiffs in the instant action and 'scare him off the Ruiz case.' He accordingly proceeded to - non-fatally - slit the writ writer's throat.....

DEAR BROTHERS AT MONGOOSE DISTRO & WORLD HUMAN RIGHTS COMMUNITY:

The AMERICAN CIVIL LIBERTIES UNION (ACLU) just released a REPORT ON PRISONS IN THE SOUTH [that includes TEXAS], OF COERRCING INCARCERATED PRISONERS TO PERFORM DEMEANING, STOOP SLAVE-LABOR JOBS, WITHOUT ANY, OR PRACTICALLY LITTLE, COMPENSATION FOR THEIR WORK, AND THOSE THAT REFUSE, THROWN INTO ITS PRISON DUNGEONS IN SOLITARY CONFINEMENT, REMAINING THEIR FOR DECADES UNDER EXTREME RACIST, BARBARIC CONDITIONS, MANY PRISONERS INSTEAD DECIDING TO TAKE THEIR OWN LIVES, COMMIT SUICIDE, THAN CONTINUE TO LIVE LIKE THESE.....See ACLU REPORT, co-authores by CLAUDIA FLORES, UNIV. GOVERNOR GEORGE W. BUSH, U. S. SENATOR JOHN CORNYN (then TEXAS ATTY GEN), and U.S. SENATOR TED CRUZ (then ASSIST. TEX. ATTY GEN., who argued cases at the SUPREME COURT and had innocent TEXAS DEATH ROW PRISONERS, such as CAMERON WILINGTON executed), and "advanced" their LAW AND ORDER TORTURE CAREER AND BUREAUCRACY ELITISM, into the higher echelons of the political power structure, WHILE BLOOD OF INNOCENTS DRIP FROM THEIR HANDS, as many Texas prisoners were beaten down, brutalized, tortured and killed by prison officials who wanted to keep these STATE CRIMES HIDDEN FROM THE PUBLIC, BUT THE POWER OF THE

UNITED TEXAS PRISONER CLASS, AND THEIR "PRISON MOVEMENT" EXPOSED THESE STATE CRIMES IN THE CELEBRATED RUIZ V. ESTELLE LITIGATION. Sadly, "reformism" under this capitalist system is a sheer fraud, in that despite many "LEGAL VICTORIES" by the prison class in Texas, in desegregating racist prisons in Texas, the censorship of prisoners who speak out in the LAMAR and GUAJARDO class actions, and the horror stories well documented in the RUIZ LITIGATION, conditions in Texas prisons, today, JULY 2022, remain worse, and daily deteriorating, as COVID 19 murders us, and the Texas heat-wave causes HEAT STROKES against us, many prisoners dying, WHILE PRISON GUARDS QUIT AND REFUSE TO WORK UNDER THESE DANGEROUS CONDITIONS, WHILE PRISONERS, LOCKED UP IN THESE CAGES, HAVE NO CHOICE BUT TO ENDURE PAIN, SUFFERING, TORTURE AND DEATH. THE RECENT ACLU REPORT substantiates our claims.....while us prisoners in prolonged solitary are being denied daily recreation periods, limited showers, fed non-nutritional meals, denied adequate medical health, and the warehousing of the MENTALLY DISABLED TORTURED BY USE OF DANGEROUS CHEMICAL AGENTS, AND THE MASSIVE SYSTEM OF POLICIES AND PRACTICES OF INSTITUTIONALIZED CRUEL AND UNUSUAL PUNISHMENTS CONTINUE, AND SOCIETY, THE COURTS, POLITICIANS REMAIN NUMB AND INDIFFERENT TO EGREGIOUS VIOLATIONS OF OUR LEGAL, CIVIL AND HUMAN RIGHTS, CONDITIONS THAT CAUSED THE ATTICA PRISONERS IN NEW YORK, TO REBEL, AS REPORTED IN INMATES OF ATTICA V. ROCKEFELLER, 453 F. 2d 12 (2nd CIR. SEPT. 1971).

PLUS, those of us, like me, who stand up and SPEAK TRUTH TO POWER, are singled out for specialized repression, harassed, have our legal, political essays, writings, censored and confiscated by racist, unit mailroom employees who dislike our "criticisms" of the prison, the government and the capitalist system, and claim that we are attempting to "encite disturbances" through our expressions of the realities we are forced to live under, conditions of torture and death not made a part of our sentences, while many of us are innocent of any crime, and were targeted by COINTELPRO EXTRAJUDICIAL POLICIES to stop us in our human rights work, OUTSIDE AND INSIDE.

PLEASE POST THIS MESSAGE ONLINE, AND GET IT TO ALL LAW SCHOOLS, CIVIL AND HUMAN RIGHTS GROUPS IN THE COUNTRY AND THE WORLD, AND ENCOURAGE THESE GROUPS TO SUPPORT THE TEXAS PRISONERS PRISON HUMAN RIGHTS MOVEMENT AS FASCISM IS ON THE RISE INSIDE AND OUTSIDE AS EVIDENCE BY RECENT SUPREME COURT DECISIONS, THE JANUARY 6TH INCIDENT, AND NEW "LAWS" ENACTED BY THE EXTREME RIGHT-WING POLITICAL POWER PLAYERS IN TEXAS, TAKING THEIR "MARCHING ORDERS" FROM WHITE SUPREMACIST PIG DONALD J. TRUMP.
